



DECLARATION signed by two International Associations for Women's Free Masons:

THE AMERICAN FEDERATION FOR WOMEN'S FREE MASONRY, «FAMAF»,

Is an organization which unites the Grand Lodges and Confederations of Women's Masonic Lodges throughout the American continent. The members respect the principles of the Constitution & the General Regulations of FAMAF and adhere to the universal Masonic ideal.

It is composed, as of the date of this Declaration, by the following Masonic Powers (in alphabetical order): Confederation of Regular Women's Grand Lodges of the United Mexican States, Women's Grand Lodge of Argentina, Women's Grand Lodge of Bolivia, Women's Grand Lodge of Chile, Women's Grand Lodge of the United States, Women's Grand Lodge of Uruguay and Women's Symbolic Grand Lodge of Venezuela.

The seat of FAMAF is located at the Grand Lodge of Chile : Calle Tegalda, no. 1881 - Ñuñoa, Santiago, Republic of Chile.

And

THE INTERNATIONAL LIAISON CENTRE OF WOMEN'S FREE MASONRY "CLIMAF",

Is an international organisation which brings together Women's Free Mason Jurisdictions with the aim of creating a space for reflection, exchange and joint action for the members, and promotes the universal values of Free Masonry in general, and of Women's Free Masonry in particular.

It is composed, at the date of this Declaration, by the following Masonic Powers (in order of membership): Women's Grand Lodge of France, Women's Grand Lodge of Belgium, Women's Grand Lodge of Switzerland, Women's Grand Lodge of Italy, Women's Grand Lodge of Germany, Women's Grand Lodge of Portugal, Women's Grand Lodge of Spain, Women's Grand Lodge of Turkey, Traditional Women's Grand Lodge of Romania - Pontus Euxinus, Women's Grand Lodge of Cameroon and the Women's Grand Lodge of Bulgaria

The seat of the CLIMAF is the Women's Grand Lodge of France : 111/113 rue de Reuilly 75012 Paris, France.

THE PURPOSE OF THIS DECLARATION IS :

1. To communicate that the two organisations assemble the representative Jurisdictions of Women Free Masons of their respective countries.
2. To announce that CLIMAF and FAMAF adhere to the principles of Universal Freemasonry and that they work with intelligence, spirit and determination so that Liberty, Equality and Fraternity may reign in societies all over the world.
3. To proclaim that CLIMAF and FAMAF defend the principles of freedom of thought and conscience, as well as the principles of Secularism, Tolerance and Justice.
4. To signify that the two organisations also share the following objectives:
 - promote reciprocal collaboration between the Women's Grand Lodges of which they are composed.
 - favour the elaboration of the Masonic methodology to attain the supreme Masonic ideal at international level.
 - facilitate the development of Women Free Mason Jurisdictions in countries where they do not yet exist, bringing the Masonic light through the creation of a Jurisdiction that will give support and contribute to the needful transmission.
 - work for dignity and rights of women in all their forms and, more generally, for the defence and respect of human rights.
 - commit that each of the Grand Lodges belonging to CLIMAF or FAMAF do not create a Lodge or a Jurisdiction in a country where another Women's Grand Lodge is already present.
